LITTLEFIELD TOWNSHIP **ROAD WORK in 2014**

With the millage this past tax year Grubaugh and Kilmer Road were wedged. This wedging process seems to be the affordable way to prolong our roads at this time. The final "Y" intersection in the Township has been replaced. This was at the corner of the South Arm of Mission Road and Banwell Road. A new intersection was engineered and completed and is a fine improvement. The last 2 of these intersections were replaced during the last 10 years. One was the intersection at Valley and Milton Roads and the other was Burley and Banwell Road. These intersections were impractical and unsafe and don't exist anymore in most townships in this area and not at all anymore in Littlefield Township. The Township has been putting away part of the millage for two years in an effort to repair the remaining section of Lakeview Road running from Banwell Rd. to Crooked Lake. Keeping roads repaired and maintained is a great challenge. The Township board uses all the millage appropriated for this purpose and more. Everyone agrees that roads matter.

PAST & FUTURE

ODEN GAZEBO PARK

PAST: Some work was done on the old Gazebo. It was stabilized, repaired and painted to make it safe and useable for the present. There was an old flowing well and the Township tried to bring it back but could not get it to flow. Two properties were acquired next to this park. One had two old yellow buildings on it which will be finding new homes soon and the other is the corner of Luce St. and US 31. The lot on the corner of Luce and 31 and the lot across from the Oden Post Office were cleared of all old concrete and dead trees.

FUTURE: We would like to put in a new flowing well and put lights on the Gazebo. There are plans to put top soil and maybe a fence on newly acquired lots. The Township plans to clean up the lot that had the two yellow buildings and to put gravel in for public parking for anyone wishing to use the new bike path.

WOODRUFF PARK

PAST: A new Flag was put up and more flowers planted and the old grill was removed.

FUTURE: The beautiful old flowing well at this park along the highway in Oden with the Veterans Memorial is in much need of either repair or replacement. We would like to add some flowering bushes and clean up some trees that have died. It is in the works to transfer ownership of this park from the State of Michigan to The Township of Littlefield.

DOW PARK

PAST: The driveway was paved.

FUTURE: Installing steps on the new flowing well to aid children and smaller adults using the drinking fountain and the flow need adjustments. Two posts need to be added along the driveway. The old light pole that is no longer in use needs to be removed.

THE OLD MARINA AND DOCKS AT HAY LAKE

PAST: Littlefield Township has an intent to purchase parts of this property and docks from the new owners of this old Marina formerly called Admiral's Point.

FUTURE: The vision is to have a public boat launch in connection with the future new Marina at Hay Lake. Gozling Czubak Engineering has been asked to work on a conceptual design and to help the Township in obtaining grants to bring about this exciting new recreational plan!

Last year the State of Michigan gave smaller businesses the opportunity to fill out an affidavit declaring the value of their personal property and to receive an exemption. Most businesses in this Township filled out that form and this year for the first time paid no personal property taxes. Since that time the voters have approved this exemption at the polls so we know that businesses will be given this opportunity again, but we have not been informed by the State of Michigan how they are going The form you will probably need to fill out yearly is called AFFADAVIT of Owner of Eligible Personal Property Claiming Exemption from Collection of Taxes (Form 5076 Michigan Department of Treasury) Please pay attention to any mail coming from your Assessor. If you are eligible, which most businesses are in Littlefield Township, you do not want to miss getting this exemption.

- Fall is a good time of the year to remove all artificial flowers, statuary, flower pots, wind chimes, any personal items, trinkets, etc. that are on your lot. - Reminder, no type of 'remembrance lights' nor any other lights may be placed on lots
