Littlefield Township ROAD WORK

Every year, Littlefield Township allocates funds for local road maintenance projects. Among the projects for 2015 was the total reconstruction of Lakeview Road; south of Banwell Rd. The road's surface was pulverized, road base reconstructed and all driveway and cross culverts replaced. This portion of the project was bid at \$149,476.00. It is anticipated the final surfacing of this road is to be completed summer of 2017.



Powers Road from the Street intersection to North Conway Road reconstructed and was paved. This was a federal aid project that totaled \$241,080.00. Of this amount, Littlefield Township provided \$20,000.00. This road is very

well traveled and really needed the work that was done.

Finally, crack sealing was done on Armock, Barney, Burley, Lakeview, Luce and Mission Road for a total of 3.91 miles. This maintenance project was bid at \$9,600.00.

This brings a total of \$179,076.00 that Littlefield Township invested in local and primary road needs in 2015.

HOMESTEAD EXEMP

Homestead Exemption - Principle Residence Exemption (PRE)

What used to be called a Homestead Exemption is now called Principle Residence Exemption PRE. This is for the home where you live most of the year, where you have your driver's license and voter registration and call home. It is only available on one dwelling. It affects your Summer Taxes and will reduce the amount of that bill by about half. Look on your bill and look under Tax Detail for the heading PRE/MBT and there is a percentage by that. That tells the percentage of the exemption you received. If you feel you are receiving or not receiving the right exemption please contact your assessor, Jim LaPeer or your treasurer, Kim Shomin.

ATTENTION ALL LOCAL BUSINESS OWNERS: The State of Michigan has for the last two years allowed smaller businesses to be exempt from the personal property tax. It is required that you file each year for this or you will be billed. The form shows up along with the form to file for this tax from your assessor. It comes out around the first of each year and must be filed on time. Look for it, read it and fill it out.

Taxes paid by this date accrue no interest or penalties

Cemetery News and Information

- The expansion of the cemetery grounds, at the north end, has been started. The first stage, tree removal, has begun with the red pines being removed this fall. There is no timetable for the completion of the expansion, but we will keep you updated.
- Cemetery lots are available for township residents at a current cost of \$200.00 for a 4-grave lot; single graves, on selected sites, are available for \$50.00 each.
- Next spring look for the new cemetery folders that will be located in the mailboxes (near the parking lots). These folders include all recorded burials and the location of each along with a map of the cemetery making locating a grave easier.

STATE MANDATED OFFICE HOURS


The Treasurer or Deputy will be on-site for tax collection on December 28, 2015, 9-5 and February 29, 2016, 9-5 Times and places will be posted at the Township Hall.

ALANSON/LITTLEFIELD

In 2015, 11 sets of turnout gear were purchased for the Alanson Littlefield Fire Department. Funds for this purchase were provided as follows: \$10,000.00 from the Baiardi Family Foundation, \$10,000.00 from the Local Revenue Sharing Board and \$10,000.00 from the Littlefield Township General Fund for a total of \$30,000.00. Since 11 sets of turnout gear were purchased in 2014, all 22 firefighters now have state of the art turnout gear.

Also, the purchase of duty boots, winter coats and gear bags for the EMS personnel was authorized in the amount of \$4,000.00
