## LITTLEFIELD TOWNSHIP SPECIAL MEETING BUDGET & PUBLIC HEARING ON TAX LEVY 2020-2021

March 26, 2020

5:30PM

Meeting called to order at 5:45PM by Supervisor, Damien Henning, Present Dean Morford, Trustee, Kim Shomin, Treasurer, and Sondra Festerling, Clerk. Absent, Katie Derrohn, Trustee.

<u>Consent Agenda was presented by D. Henning</u> with adjustments made to #8: Motions to Adjust the Budgets (as seen below \*adjusted\*).

- **#3) Minutes** of March 26, 2019 Public Hearing on Budgets and Tax Levy was presented. The Minutes were approved at the April 2, 2019 Regular Board Meeting, and were accepted as presented.
- **#5) Payment of bills** totaling \$55,057.54 (\*adjusted\*) approved for payment from the General Fund.

## #6) Motions:

- a) The Littlefield Township Board Meeting will be on the first Tuesday of each month.

- D. Henning **Moved** that the Assessors salary be \$36,800.00 Annually, Second by S. Festerling, Carried 4 Yes, 0 No, 1 Absent.

  - -Board of Review members will be paid \$16.00 per hour.

Second by K. Shomin, Carried 4 Yes, 0 No, 1 Absent.

- D. Henning **Moved** that the **Cemetery Sexton** shall be paid \$2,300.00 per year, second by S. Festerling, Carried 4 Yes, 0 No, 1 Absent.
- S. Festerling **Moved** to pay Township Supervisor D. Henning up to an additional \$13,000.00 for any extra meetings for any Litigation and any other Special Project Meetings during the 2020 2021 Budget Year. Second by K. Shomin, Carried 4 Yes, 0 No, 1 Absent.
- S. Festerling **Moved** that D. Morford be paid a \$35.00 per diem for any special meetings he attends with D. Henning on the Admirals Point Project during the 2020-2021 Budget Year. Second by D. Henning, Carried 4 Yes, 0 No, 1 Absent.

BUDGETS WERE PREPARED FOR THE 2020-2021 YEAR: General Fund Revenue of \$520,118.00 and Expenses of \$446,330.00. Sewer Fund Revenue of \$253,491.00 and Expenses of \$267,700.00. Cemetery Fund Revenue of \$1,195.00 and Expenses of \$3,000.00 with the deficit coming from Cemetery Fund- Fund Ballance. Oden Light Revenue of \$11,876.00, and Expenses of \$11,500.00. Fire Fund Revenue of \$172,342.00, and Expenses of \$163,277.00. Hay Lake Marina Fund Revenue of \$466,200.00 and Expenses of \$1,056,670.00 leaving a deficiency of \$(590,470.00). The expense deficiency is decreased to a deficiency of \$(245,766.00) due to a fund balance beginning of \$344,704.00. The remaining deficiency could be adjusted lower once the remaining 3 expenses are put out for bid (Landscaping, Fuel System, and Service Attendants Booth) and if the Construction Contingency comes in lower than the \$100,000.00 originally budgeted from last year. Any remaining deficiency after the project is completed would be transferred from the General Fund- Fund Balance. The Public Hearing was closed and the above Budgets were presented, revised, and moved for approval by D. Morford, Second by K. Shomin, Carried 4 Yes, 0 No, 1 Absent.

- S. Festerling made the **Motion** to remove Agenda Item #11 Special Meeting of the Election Committee since the details of the May 5, 2020 Special Election is still being decided by the State of Michigan. Second by K. Shomin, Carried 4 Yes, 0 No 1 Absent. A special posting of Election Committee Meeting will be in the near future.
- S. Festerling also informed the Township Board that she will be deputizing Casey Festerling to help with the added work load an all absentee ballot election will create. The distancing requirements don't restrict us from working side by side since we live in the same household. Our township has close to 2,600 registered voters. Due to COVID-19 restrictions, the Secretary of State sent out letters to all registered voters explaining how the Stay at Home & Stay Safe order has affected the upcoming election and included the necessary application to get an AV Ballot. We could see a much higher than normal turnout since most people are at home not working, and everyone has been sent this opportunity to vote postage free.

After a discussion about all the upcoming 2020 Elections and the increased work load that has gone into effect for holding and managing the changes to elections, D. Morford made a **Motion** to pay Sondra Festerling the Election Inspectors rate of \$16.00 per hour for any additional labor created from the passing of ballot proposal 18-3 on elections above the minimum statutory duties, to process Absent Voter Ballot Requests, and to be compensated for the additional labor it takes to do the work that was previously done by Emmet County for Littlefield Township. Second D. Henning, Carried 4 Yes, 0 No, 1 Absent.

D. Henning made a **Motion** due to the issues surrounding the Corona Virus and lack of agenda items, the Regular Township Board Meeting will not be held on April 7<sup>th</sup>, 2020. Second by K. Shomin, Carried 4 Yes, 0 No, 1 Absent. The notice of cancellation will be posted on the Hall and township website. D. Henning will contact Joel Wurster for guidance on a Post Audit Policy allowing the Clerk and Treasurer the ability to pay certain specific payments in-between Regular Meetings that would be approved by the Board at the next held Regular Meeting. If a policy is drafted with the help of our attorney the Township Board can hold a Special Meeting to adopt it.

S. Festerling made a **Motion** to move the Regular May 2020 Board meeting to Thursday May 7<sup>th</sup>, 2020 due to the May 5, 2020 Special Election being held during our normal Regular Board Meeting time. Second by D. Henning. Carried 4 Yes, 0 No, 1 Absent.

There were no other items to come before the board. D. Henning Moved to Adjourn Special Meeting Budget & Public Hearing on Tax Levy at <u>9:00 PM.</u>
